# The Demise of POTS...


In 2025, the copper telephone network will be switched off completely. It's also known as the Public Switched Telephone Network (PSTN) or Plain Old Telephone System (POTS) and is the socket on the wall that landline phones and/or your internet router plugs into.

From 2023, you will no longer be able to purchase any copper-based services. Because Chorltonville has historically not had fibre connections, broadband was provided initially via copper throughout and more recently via Fibre Through To Cabinet (FTTC) and then copper from there to individual houses.

Fibre cable is currently being installed throughout the 'Ville via the existing BT underground distribution. Very soon, residents should be able to purchase FTTP (Fibre Through To Premises, aka Full Fibre) broadband connections. Internet Service Providers (ISPs) should be able to offer this as soon as the availability is released.

By 2025, anyone wishing to use a 'landline' type telephone (nonmobile) will need to upgrade their account with their provider to a VoIP system.

VoIP is Voice over Internet Protocol. A standard handset can be used for this facility, but it would plug directly into the router and not into the wall socket. Older routers may not have this connection, so a router upgrade may be necessary. Moving to a FTTP connection would necessitate your provider supplying a new router anyway.



#### So - big question: Do residents have to upgrade to FTTP?

At the moment that is a difficult one to answer and may depend on your

provider. There is no plan to strip out the copper wire as far as we know, but telephone signals won't be pushed down it after 2025. Local maintenance and repair may also become non-existent. However, as the copper will still be there from cabinet to houses, some providers may still maintain a broadband service via this route. At least for a short time after 2025.

What is clear, however, is that if you wish to continue using a landline-style telephone, you will need to change to a VoIP based system before the end of 2025. Your current landline provider should inform you of this.

## **CHORLTONVILLE SCARECROW GARDENS**

# Spot the Difference...



One of the Chorltonville Committee's tasks is to oversee the management of trees in the public spaces of the 'Ville. This task is complicated by the fact that trees grow as can be seen in our "before



and after" pictures above. We are unsure of the date of the first picture (second is 2023). Some trees have been removed but some have grown significantly. While trees contribute to the charm of Chorltonville, their management poses a problem. Due to the Conservation Area protection, we can only remove or prune trees that are considered diseased or dangerous and then, only after Council approval.

While the committee has no remit regarding trees in private gardens, we would like to remind residents that their own garden trees are covered by the same Conservation Area protection. For any work on or removal of garden trees, residents must give Manchester City Council at least six weeks' notice.
